

Registration and payment procedure

A valid 2026 FAI Sporting Licence is required and must be obtained through the competitor's NAC (National Airsport Control). All competitors must be registered by their NAC before completing the registration process with the Organizer.

*NOTE to NACs:

The name of competitors on the entry form must be EXACTLY the same as the one listed in the FAI Sporting License Database.

PROVISIONAL ENTRY (FOR NACS)

Each NAC will receive a secure PDF form to fill out with information regarding the teams representing their respective country, such as:

Number of teams / competitors in each event/category.

Name and birthdate of each team member.

Name of team captain + his/her contact information.

FAI IDs for each team member, (see "NOTE" above)

Indication of team members participating in more than one event.

Indication if the NAC is paying for the delegations or if teams pay Bank transfer only

Once the form is complete with the information above, NAC representatives will close the entry and make it official by affixing their seal. The Organizer will then receive the official entry and have the necessary information to contact all team captains to finalize the registration process.

Deadline for provisional entry: January 25, 2026







APPLICATION FOR IPS ATHLETE EVALUATION (FOR COMPETITORS via NACS)

To request an Athlete Evaluation, athletes must submit following Diagnostic Information and Supporting Documents to their NACS:

- a. The completed and signed official Athlete Evaluation, Declaration, and Consent Form (see COMPETITION RULES INDOOR PARA SKYDIVING ANNEX 2), which allows Competitors to disclose their underlying health condition, the nature of their Eligible Impairment(s), and commitment to adhering to the Classification Rules.
- b. One or more photos or video images supporting the medical diagnosis for Physical Impairments (PI).
- c. One or more video images of the athlete in flight in a wind tunnel, using any Specific Equipment if applicable. These videos must demonstrate either: flights during an IPS competition, or the athlete's ability to fly up, down, forward, and backward, as well as their ability to contact the inner wall of the flight chamber.
- d. An official Medical Diagnostic Form (COMPETITION RULES INDOOR PARA SKYDIVING ANNEX 2) signed by a qualified medical doctor and supporting documentation, providing the classification panel information on the Athlete's health condition, which eligible impairment it may lead to, and the extent to which the health condition impacts

Diagnostic Information and Supporting Documents must be provided in its original format (i.e., the original document or a copy thereof) along with an English translation (if the original format is in another language).

FINAL ENTRY (FOR COMPETITORS)

Based on the information transferred by the NACs, each team captain will receive a secure PDF registration form by email and will be required to submit additional details to the Organizer, proof of bank transfer (if the registration fees haven't already been paid by the NAC) and team members' contact details and t-shirt size.

The invoice confirming the payment will be sent to the team captain as soon as possible upon receiving their registration form.

Deadline for final submission: February 22, 2026

**Please note that only NAC representatives can change the number of teams or team members registered.

Late entries fees: Entries after the deadline will be approved only if capacity allows, and subject to 50 €/participant

Windtunnel facilities

WEEMBI provides space over two floors and the usual facilities such as a bar and club house.

There will be networked computers and printers located in the building for the competition staff, FAI/ISC officials, and judge panels. A meeting room will be dedicated to officials and administrative purposes in general.

There will be internet access with dedicated access for the judges, the media and officials.

There are male, female and disabled persons facilities.

The general public and flyers are welcomed in a large area around the flight chamber.



- consistent power from the grid to 14 meters
- 290 K/H max speed
- 2 comfortable pre-flight chambers
 - o 16.5 m2 (suitable for 2 FS 8 way teams walking their flight)
 - o 64 m2
- T° control from 20 to 45 ° C
- Door: H 185 cm x W 65 cm
- All equipment required is ready and operational for all competition jumps/performances and all official training jumps/performances.
- Many TVs to broadcast the flights and the scores live.

Equipment and other details

Helmet and one-piece suit recommended.

Athletes, including IPS athletes, are reminded to provide their Therapeutic Use Exemption (TUE) certificate for all substances listed on the WADA Prohibited List.

The Weembi facilities will be made available to athletes, particularly IPS athletes who will have a dedicated area for preparation and care (or treatment/recovery).

Judging & Scoring

Electronic scoring equipment: In time scoring

IPS scoring system: CTS Digital

The flight chamber is equipped with bottom, top and side cameras suitable for all events.

Medical / emergency details

Full time first aid support, paramedics and doctor on site.

Ambulance and emergency services will be available in connection with Lille Hospital, 15 min by car from Weembi (10 km).

Details of event insurance

The Organizer has insurance coverage in an adequate amount in connection with the event including public liability insurance meeting the applicable legal specifications. This coverage will be presented to the FAI at the earliest opportunity, according to the FCEAD requirements.

The FAI, its respective directors, employees and assigned event Personnel will be designated as additional insured parties.

Details of insurance required by participant

Insurance required: third party liability and medical repatriation.

Each participant is responsible for their own personal medical repatriation insurance.

Each participant is responsible for their own personal third party liability.
